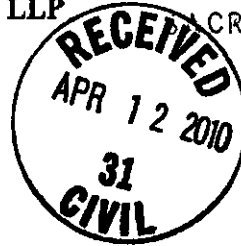

27 behalf of Defendant, BRENT HANSON.


28 Upon review of the moving papers and the argument of Plaintiff and counsel, and GOOD


