

You have reached a page on LasikFraud.com which has temporarily been removed from public view on April 24, 2010, due to ongoing litigation in Sacramento Superior Court

While the court has not directly ordered any of the documents to be removed from LasikFraud.com, the court has ordered some of the documents to be removed from the Sacramento Superior Court's online docket. The web site operator has temporarily removed the documents from LasikFraud.com to avoid having the issue come before the court, as to whether the order even applies to LasikFraud.com.

The documents that were originally located at this URL described a small snapshot of communications between Glenn Hagele and Patrick Mobley, a convicted felon from Texas. The communications between Hagele and Mobley describe their wide ranging criminal activities on behalf of multiple LASIK surgeons, which included the following:

1. Multiple burglaries of the residence of the operator of LasikFraud.com.
2. Thefts of documents from the computer owned by the operator of LasikFraud.com.
3. Intercepted electronic communications, including both e-mails and by telephone of the operator of LasikFraud.com. The intercepted communications were related to litigation, discussions between LASIK patients to the FDA, and involved a reporter from the New York Times.
4. Electronic hacking of bank account owned by the operator of LasikFraud.com.
5. Schemes to falsely arrest and charge the operator of LasikFraud.com with possession of cocaine -- a scheme which failed when Mobley claimed to have been arrested while purchasing drugs.
6. The sale of documents to LASIK surgeons affiliated with Glenn Hagele.

The documents you are seeking to view will become available in the future, immediately after a lawsuit is filed against the following entities and persons in Sacramento Superior Court

Glenn Hagele, Council for Refractive Surgery Quality Assurance, aka "CRSQA", Kenneth Hagele, Patrick Mobley, Keith Croes, David Foos, Robert Buffington, Jay Bansal, Scott Behler, Robert Brems, Stephen Brint, Benjamin Chang, Daniel Durrie, Richard Foulkes, Raymond Gailitis, Robert Gladsden, Daniel Goldberg, Jack Holladay, Thierry Hufnagel, Kent Kirk, Robert Lin, James Loden, Robert Maloney, James McDonald, Sanford Moretsky, Philip Roholt, Cary Silverman, Swati Singh, Gregory Stainer, Steven Stetson, and Marc Werner.
