1st Affidavit of Brent Hanson

Brent Hanson, being first duly sworn upon oath, deposes and says:

1. I am the Defendant in this lawsuit. I submit this 1st Affidavit of Brent Hanson in support of DEFENDANT'S MOTION TO QUASH SERVICE OF SUMMONS.

2. I have never been served with a summons for this lawsuit.

3. I have never received any notification from the Court regarding the trial on December 23, 2008.

4. I first learned of this lawsuit on December 10, 2008 when Plaintiff sent an e-mail containing a scanned copy of a complaint to the National Arbitration Forum. Plaintiff's complaint to the National Arbitration Forum is an action to seek control of the domain name www.usaeyes.us, which I currently own. Plaintiff sent a copy to my e-mail account. Buried within the complaint to the National Arbitration was a scanned copy of SMALL CLAIM NO. 85-11924, as Annex 27-CRSQA v Hanson.pdf. This annex was contained within a voluminous compressed computer file of documents.

3. An additional scanned document was contained within Annex 27-CRSQA v Hanson.pdf titled "Offer and Compromise" which was dated December 3, 2008. The letter purports to be sent from Plaintiff to Defendant "via personal service" and includes the following false statement:

"You have now been served, with the above referenced small claim action against you"

4. The mailing address contained in the letter is not my address. It is for the leasing office of an apartment complex.

5. The only time I have been contacted by a representative of Plaintiff in the State of Washington, was when my attorney and I received a series of anonymous e-mails in the beginning of November 2008. The sender indicated that he was he was a private investigator who had been hired by Plaintiff in November 2007. The sender provided samples of correspondence from Plaintiff, and claimed to have possession of 138 communications from the Plaintiff that directly implicates the Plaintiff in criminal activities across multiple states. One of the samples contained detailed personal information about myself that is only available from multiple privately owned corporate databases. The sender further indicated that there was a rift between himself and Plaintiff, and that he wished to sell the communications from Plaintiff to me.

The e-mails have been provided to the Washington Department of Licensing, and will be forwarded to the FBI's field office in Sacramento, California. I believe that Ron Belec, the owner of Northwest Legal Support is the author of the e-mail messages.

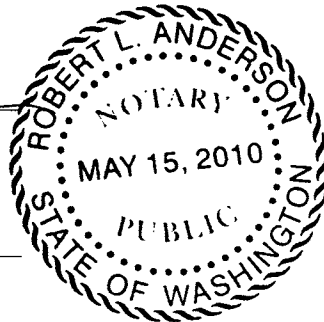
